It can be achieved by:

- > Supporting the vision of Predator Free New Zealand 2050.
- > Committing to achievement of the declared PFNZ 2025 goals, including the complete removal of all introduced predators from offshore island nature reserves.
- > Continuing to prioritise and increase funding for Battle for Our Birds.
- > Increasing funding for protection of our special mountain bird, the kea.
