About the grant

The Federated Mountain Clubs of New Zealand, through the support of the FMC Mountain and Forest Trust, is pleased to be able to offer cash grants aimed at benefitting FMC clubs, and the institution of clubs, through the increased abilities of their members.

What kind of training is eligible?

Any training which can be justified to have an end benefit to an FMC Club.

Who can apply?

- The applicant should be the person in the club who is organising the training activity.
- The application must be endorsed by the club Treasurer.

Who is eligible to receive a grant?

- Grants will only be paid directly to FMC Affiliated Clubs, on a reimbursement basis.
- Proof of expenditure and/or receipts (as negotiated with FMC) will be required before payment.

What expenses can be funded?

- Any bona-fide expense which is required to achieve the training. Equipment will not be funded.

How will FMC decide where the funding goes?

The FMC Scholarship sub-committee allocates the grants, based on these priorities:

Who is involved

1. Club-organised training in collaboration with other FMC clubs.
2. Club-organised training only available to its own members.
3. Professional courses, where the aim is to benefit club trip leaders.
4. Professional courses for the benefit of any club member.

The content of the training

1. Leadership for the backcountry
2. Club (non-outdoor) leadership, governance, management, administration, IT for club officers etc.
3. Specific mountain 'hard-skills' which trip leaders require.
4. General mountain skills for any outdoors person.

Grant dates: *make sure you apply in time, as late applications may not be considered.*

- Applications close 15 September.
- Grants will be awarded in October.

On behalf of my club, I declare that should this application be successful, the club agrees that:

1. The grant will be paid after the course has been conducted, and once the following criteria are met;
 - a. For professionally run courses, your club must supply receipts for those costs.
 - b. For club-organised courses, your club must supply:
 - i. Evidence that the course took place, (photographs and a declaration by the course organiser.)
 - ii. Receipts for any items over \$200.
2. You will provide Federated Mountain Clubs with a brief report (400-800 words) and at least 4 photos of the training that is suitable for social media within 1 month of the course.
3. You will ensure that any people described or contained within the photographs consent to FMC publishing the report and photos in any of our communications, in order to promote the grant if we choose to do so.
4. If such a report is published separately from FMC, it will include an acknowledgement of the financial support of the FMC Mountain and Forest Trust to the training.
