Whakapapa Village Parking Area and Restrictions

The Department of Conservation (the Department) received comments and feedback from you regarding our proposed parking restrictions in Whakapapa Village (the Village). We are writing to let you know the outcome of the consultation process.

Any feedback provided that is not directly related to the proposed Whakapapa Village public parking areas and restrictions has not been considered.

The formal public notification process generated sixteen submissions and a detailed summary of the feedback is provided in Table 1 (Appendix 1). The feedback has been grouped into five themes:

- Parking Permits Day, Overnight and Multi-Day
- Taranaki Falls Car Park closure
- "No Stopping" zones
- Whakapapa Village Bus Park
- One and three-hour parking restrictions

Strategic approach

The Department is adopting a strategic and consistent approach to the overall management of parking in Whakapapa Village by utilising the new parallel parking areas opposite the bus park, State Highway 48 for private vehicles for 3-hour, day, overnight and multi-day parking. It is a safe parking area for the public to exit their vehicles, close enough to local tracks and amenities, and has good lighting, for security purposes.

Outcomes

We have considered the submissions against the strategic approach and confirm the following outcomes, based on the five themes.

1. Parking Permits - Day, Overnight and Multi-Day

You can phone, visit or email the Tongariro National Park Visitor Centre in Whakapapa Village to obtain a permit in the new parking areas for day, overnight and multi-day parking. The Department does not propose to implement an online permit system at this time but will consider this option in the future.

2. Taranaki Falls Car Park closure

The existing Taranaki Falls carpark is small, beyond its useful life and no longer suitable as a carpark. The carpark will be closed to align with our strategic approach for managing parking in the Village, however drop offs are permitted.

3. "No Stopping' zones

"No stopping" zones are strategically located within the village for safety reasons, emergency services access and to assist snow clearing during the winter season. 'No stopping' zones in Ngauruhoe Terrace aligns with our strategic approach for managing parking in the village. There is sufficient parking to cater for the broad group of recreation park users that visit the Tongariro National Park all year round.

4. Whakapapa Village Bus Park

The Departments observations from the 2020 winter season, is that ceasing use of the Whakapapa Village Bus Park as a transport hub in conjunction with the 3-hour parking restrictions in winter, achieved our core objectives to manage traffic congestion, flow and safety risks. We will continue to support the use of shuttle services from 'Park and Ride' facilities in National Park Village and Ohakune, as well as from local towns such as Turangi and Taupo. The Bus Park is also available for large coach buses, shuttle transfers from 2WD vehicles to 4WD during road restricted days and as a safe self-chain fitting area for private vehicles.

5. One and three-hour parking

One-hour parking restrictions applies all year round and caters for visitors wanting information or purchase goods and services from local businesses. The 3-hour parking restrictions in winter is intended to cater for visitors to local short walks and other amenities in Whakapapa Village, with the provision to park longer than 3-hours by permit. In summer, the 3-hour restrictions become all day parking.

Please see the map attached that illustrates the restrictions and locations.

| Parking Permits -Day, Overnight & Multi-Day An 'in person' permit system denies the ability to make last minute decisions on outdoor activities based on the weather and conditions. We do not support the lack of provision for overnight car parking without a permit. Whakapapa is the starting point for a number of overnight and multi-day tramps. Esp in summer months, when backcountry recreationist will seek early starts, the requirement for people to personally attend the VC for a permit could cause unreasonable delays to people starting their day, resulting in unnecessary time pressure on the trail. We do not support the lack of provision for day parking without a permit for reasons similar to above. We understand that this is to discourage ski field patrons parking in Whakapapa Village. It would be entirely feasible to have shuttles from National Park Village act as 'drop off only' at Whakapapa Village, so there is no mechanism for the provision of day parking to be abused this way. I cannot see the problem with all day parking at any time along the roadside. The new carpark and the old bus park should also allow all day parking and it is here that any overnight parking should be allowed on a strictly permit only basis for Northern | Online permit system so they can be easily obtained without altering trip plans, or indeed, to aid the appropriate altering of trip plans so recreationists can make safe decisions. Propose that the parking opposite the bus park be a designated overnight park year-round. We would like to see the green zones be day parks year-round. Provision for all day and multi day parking Change VC hours from 8am - 5pm to 7am - 4 pm or update website to include a web form to apply online, print out and leave on dash. Pre-arranged online system or by email DOC create an app to allow for self-registration. The app could inform users of where they can park, update on any changes to parking restrictions. | DOC does not propose to implement an online parking permit system at this time, as it has the potential to be exploited, especially during the winter season. We will however consider this option in the future. Day, overnight and multiday parking permits are available via email from the Tongariro National Park Visitor Centre in Whakapapa Village. DOC does propose to utilise the new parallel parking facility opposite the bus park for overnight parking, but by permit only. It is a safe parking area for the public to exit their vehicles, close enough to local tracks and amenities, and has good lighting near Chateau Tongariro, for security purposes. DOC assumes that backcountry recreationists are experienced at planning their overnight and multi-day trips in Tongariro National Park. DOC encourages visitors, particularly those with no or limited tramping experience, to talk to the visitor centre staff, get the latest safety and weather updates and collect their backcountry |

| Circuit, Round the Mountain etc park users. Explain how extended parking permits will work. Many people will want to leave vehicles for longer periods when going further afield than Taranaki I come to tramp and generally longer trips than 3-hours or overnight to multi-night tramps. Whakapapa is a good base to leave the car with some element of safety as many trip possibilities start from there. Day trips from Whakapapa Village to Whakapapaiti hut, or the Tama Lakes take greater than 3 hours, or can be the start of many longer trip possibilities. Please make some limited provision for these eventualities. Support in principal but unclear what is happening to, day/multi day passes for hikers. Parking permits for hikers hard and impractical to obtain before the VC opens at 8.00 am My personal want is to park there daily so I can use the park, but not the commercial area. I regularly travel to the park in hours where the visitor centre is closed. It's not clear if there is a way to get parking permits outside of VC hours. As a multiday tramper, I have used the parking facilities and found them ideal for overnight parking. By n large I agree with the proposed changes. However, I would like you to consider an alternative means of arranging parking for those wishing to stay longer than 3 hours. Often I arrive and want to begin walking before the VC opens. What would the purpose of having bus pick ups at whakapapa village if there is no where to leave your car during winter. If the primary pick up point is supposed to be in National Park then that would need to be communicated as most people would take the bus up from the village. Turning the 60 min parking spots into 3 hour ones would then allow guests to visit the village to take the short walks in the vicinity.
