1. Be a member of an FMC Member Club or an FMC Individual Supporter.
2. Consent to the nomination and have the time, passion and skills for the role for the two year term.
3. Be available for the first Executive meeting in Wellington on 13 June 2026.
4. Certify that they are not disqualified under section 47(3) of the Incorporated Societies Act from being appointed or holding office as an Officer of the Society.
5. Provide a profile (max 250 words) with this nomination form, including a photograph of themselves, for publication on the FMC website.
